

Dear Guests,

In welcoming you to the Parco della Gallinara Camping Village, the Management invites you to read these Regulations as they are an integral part of the camping seasonal tourist contract.

The rules listed below are intended to create the best conditions for a respectful coexistence within the Camping Village, whose entry constitutes unconditional acceptance.

ENTRANCE TO THE CAMPING VILLAGE

1. For Public Safety provisions, upon arrival it is mandatory to carry out the Check-in procedures by providing an identity document of each member of the crew who will stay in the Camping Village for the summer season 2022. The composition of the crew, once the check-in procedures have been completed, can no longer be changed. The Crew Chief, holder of the registration, is personally and criminally liable for the omission of such registration.
2. At the end of the registration and payment procedures for the entire annual fee, you will be provided with pass bracelets valid as a personal document and will be used for identification checks by our staff. For this reason it is strictly forbidden to exchange and / or give the bracelet to third parties. In the event of this circumstance, the Crew Chief will have to pay the amount of € 100.00 as a penalty and the Management reserves the right to terminate the Camping Contract. The bracelets allow access to the gates of the campsite. In case of loss it will be possible to request a copy at the Reception at the price of € 5.00.
3. The annual rental fee (see the current price list) is calculated on the basis of a standard crew of 4 people. A maximum of 3 additional people can be added to the crew and each additional member will have to pay an extra fee of € 200.00 (two hundred / 00 euros). For children under the age of 3, who do not compete to form the maximum number of crew (7 people), no payment will be due.

GUESTS VISITORS

4. Campers can host day or overnight guests by sending a request by email to: reservation@parcodellagallinara.com specifying the date , duration of the stay as well as name, last name, the licence plate of the guests. We remind you that passes shall be paid no later than the opening hours of the Fast Cash office displayed at the Reception. In the event that the guest arrives after closing time, they can collect the pass at the security guard if previously booked and paid for. **WITHOUT A PASS IT WILL NOT BE POSSIBLE TO ACCESS THE STRUCTURE.** We also remind you that campers are responsible for the behavior of their guests and must ensure that they hold a regular pass.
5. **OVERNIGHT VISITORS:** Guests staying overnight must carry out the check-in procedures, showing a valid identity document, pay (as per the Price List) the stay, parking and tourist tax. A bracelet will be issued, which must be returned at the time of check out scheduled for 12:00 on the day of departure. In case of irregular check out , including non returning the pass, the crew chief will be charged the next nights as per price list. In case of a pet, the cost is € 3.00 per day. In compliance with the provisions of art. 109 of the TULP (Consolidated Law on Public Safety), minors can access the campsite with a valid identification document in addition to the authorization signed by both parents, together with a copy of an identification document of the latter, or accompanied by adults who are the legal responsible.

6. DAILY VISITORS: Access allowed from 08:00 to 23:30, upon registration and payment as per the price list. A pass will be issued which must be returned to the control staff at the exit. In case of non-return, the cost of the overnight stay will be charged to the Crew Chief until the return of the same. In the case of a pet, the cost is € 3.00 per day.

We remind you that after 6:00 pm you will pay only for the parking. No pass will be issued and the tax receipt issued by the Fast Cash office will be valid.

7. It will not be possible to accommodate guests if the crew is full. We remind you that the number of people making up the crew shall not change and any overnight guests may not exceed the allowed number of 7 people. Given that it is absolutely forbidden to sublease and / or give the pitch on loan for use, no guest will be able to access it unless at least one adult member of the crew is present.

8. The access and presence in the Camping Village of persons not authorized by the Management involves:

- Violation of the Public Safety Regulations;
- Violation of Art. 633 C.P. (invasion of land and buildings);
- Violation of Art. 624 C.P. (theft of services);
- Crime of contractual fraud.

9. The presence of unregistered visitors will result in the immediate termination of the contract by law, pursuant to Article 1456 of the Italian Civil Code and the application of the provisions of the previous point.

10. For each pitch, a maximum of 3 plates might be registered. Further vehicles will be regulated as per the specific price list.

THE PAYMENTS:

11. The payment of the entire rent, including the deposit / storage fee and the seasonal tourist camping contract, must be made before entering the Structure, paying the deposit by 20 December 2021 and the balance by 20 March 2022, as indicated by the Company. In the event of a bank transfer, the ordering value date expressed on the accountant will prevail. IT WILL NOT BE POSSIBLE TO DO CHECK-IN IN THE LACK OF THE BALANCE OF THE SEASON OR IN CASE OF SLOPES FROM PREVIOUS YEARS.

12. As per the Municipal Regulations, the payment of the Tourist Tax is due. The rate will be flat rate according to the regulations in force.

13. The sale of any structure owned by the Campers or passage of a pitch must be communicated to the Management which reserves the right to allow or deny the entry of a new customer and / or to confirm the possible availability of the same pitch.

14. The camper who does not intend to renew the seasonal tourist camping contract for the following season is required to communicate it within the peremptory deadline of September 30th and to remove his / her caravan with annexes by December 31st. If the camper, with his structure, occupies the pitch after this date, without communicating the intention not to renew the contract, the same will be automatically renewed for the new season. The camper will be required to pay the entire annual fee for storage and for the seasonal tourist camping contract, to the extent indicated by the Company. In the case of payment of

the storage only, it is not allowed to access the Camping Structure, but only the Crew Chief will be able to enter his pitch by feet and for a maximum duration of 30 minutes from Mon to Fri excluding holidays.

15. Contract renewal does not constitute a pre-assignment for the pitch. Ginestre Village S.r.l. reserves the right, at its sole discretion, to choose and modify the pitches on which to place the crews.

PETS

16. It is mandatory to report the presence of pets at the time of check-in and to pay the fee of € 50.00 for each animal. They will be admitted only and exclusively upon presentation of the health card. A maximum of 2 pets are allowed per crew. Other pets are allowed only at the discretion of the Management and in compliance with any applicable legislation. Hiding the presence of a pet will result in the Company sending the warning letter with consequent provision.

17. All animals must be kept in such a way as not to cause disturbance or damage to other people or things. Their owners will be responsible for any damage to people or things.

18. It is forbidden to shower animals inside the toilets.

19. Owners shall accompany their dog to the Dog Area for manure and shall remove it immediately.

20. The access of pets in the authorized areas is allowed only if they have a muzzle.

FEW RULES TO RESPECT

21. Inside the Camping Village there are special pillars that show the pitch number and delimit the space (max 100 square meters), where this is not already defined by the pine trees. It is strictly forbidden to occupy more space. Only in exceptional cases, assessed from time to time at the sole discretion of the Management, will it be possible to increase the surface area of the pitch at an extra annual fee of € 25.00 per square meter. The pitches cannot be occupied with structures other than those authorized in writing by the Management.

22. For the execution on one's own structure and / or pitch of works that exceed the ordinary administration (Installation, Pre-entrance, Kitchenette, Gazebo, Flooring, Fence, etc.) it is mandatory to provide written communication to the Management with a minimum notice 20 days, by sending an e-mail to: amministrazione@parcodellagallinara.com. The Management will evaluate the intervention and, where authorized, will provide the specific methods of execution. Ordinary maintenance work on the campers' facilities can be carried out in the months of April and May, from 09.00 to 13.00 and from 16.00 to 19.00 every day, Saturday and Sunday included. From the second Sunday of May until the second Friday of June, noisy works can be carried out from 09.00 to 13.00 and from 16.00 to 19.00, excluding Saturdays and Sundays. Any type of work outside the periods indicated above is prohibited, unless expressly agreed in writing with the Management. For the aforementioned works, entry to vehicles other than those registered will not be allowed unless authorized in writing by the Management.

23. A light fence made exclusively of the following hedges belonging to the Mediterranean scrub and present on the Lazio coast is allowed: Pistacia Lentiscus, Myrtus Tarentina, Phillirea Angustifolia, Eleagnus Ebb. Aura. We remind you to take care of the hedges surrounding your pitch, leaving them at a height of 1.50m.

24. It will be possible to place a green fence or a wooden fence, for a maximum height of cm. 70.

ATTENTION: the net must be positioned only and exclusively inside the hedge where present. All the

support posts must be without the tip, if metal capsules and / or lids made of plastic or similar must be applied to the upper end.

26. For campers without pre-entry it is possible to place a green cover supported by metal poles over the caravan or, in case of renovation of the structure, a wooden gazebo for a maximum size of mt. 6 x 6 and a maximum height of mt. 3.20. A gazebo with a maximum size of mt. 3 x 3 and a maximum height not exceeding 20 centimeters compared to the height of the housing unit to which it is attached. Otherwise, for campers with pre-entry it is only possible to install an umbrella without additional gazebos.

27. Inside the pitch it is possible to install a regular kitchenette for camping with a maximum size of 4 sqm and a maximum height of 2.50 mt. which must be disassembled and made of wood exclusively by a company authorized by the Management.

28. All Caravan owners are required to keep the facilities and pitches in a state of decorum and safety.

29. It is allowed to pave no more than 18 square meters of pitch by laying the bricks directly on the ground without the aid of sand or other materials.

30. The campers and caravans with their towing vehicles must be in compliance with the legal regulations on road traffic, liability insurance and fire and with the provisions issued by the customs and tax authorities, the users remaining fully responsible in this regard.

31. For any extraordinary maintenance work, the written authorization of the Management is required. The staff of the Camping Village is expressly authorized to immediately remove, without notice, any installation contrary to these Regulations.

32. The supply of electricity to the pitches is of 1.5 kw. Each customer must use the socket corresponding to the assigned pitch. Any unauthorized connection or tampering with the sockets is a crime punishable under Article 624 of the Criminal Code. Any transgressor will be reported to the competent authorities and will be deemed to be in breach of the contractual obligations assumed, with possible termination of the Camping contract.

33. The staff of the Camping Village is expressly authorized to immediately detach, without notice, any cable and / or other instrument affixed in violation of the preceding paragraph.

34. Anyone tampering with or causing damage to a column will have to bear the cost of the repair, prepared and managed by the Camping Village. Where it is not possible to identify the Manager, the cost will be divided among all users connected to the same column.

35. In accordance with the law, to avoid waste of electricity, the following provisions must be observed:

- the lighting lamps must be of the LED type, watertight, with ground drainage, not exceeding a height of 60 cm. Up to a maximum of 4 light points per pitch and 1 light point per veranda are allowed;

- the use of only one refrigerator is allowed and other appliances powered by electricity are prohibited;

- the lamps used to illuminate verandas and pitches must be turned off when there are no people on the pitch, during the night and during the day.

36. Any work consisting of cemented or dry stone walls will be immediately removed at the expense of the camper who will also have to bear the cost of sending the resulting material to the landfill. It is absolutely forbidden to place any electrical, plumbing and / or radio and television system on the trees. It is forbidden to lay cables and electrical wires between one tree and another. These installations will be immediately removed by the Camping Village staff and taken to the landfill at the expense of the camper.
37. Watering must be MANDATORY with the drip system, exclusively during the opening period of the Campsite. No further water point is allowed.
38. It is absolutely forbidden to use a water hose to water the streets, wash cars, covers ect.
39. It is absolutely forbidden to connect the caravan bibot to the sewer system.
40. A water and a gas outlet are allowed inside the kitchenette, the drain must be connected to the sewer system.
41. Washing machines inside the pitches are prohibited.
42. Only one connection to the electricity network is allowed.
43. During the winter closing period, access to the Camping Village is allowed by appointment at least three days in advance. Access is allowed only to the Crew Chief, by feet for a duration of 30 minutes from Monday to Friday, excluding holidays.
44. No member of our staff will be able to collect / store packages and / or correspondence from postmen and / or couriers on behalf of campers.
45. The violation of any of the points indicated above will result in a disciplinary reminder evaluated at the discretion of the Management.

THINK GREEN

Campers are required to carry out separate collection, in compliance with current legislation, using the special containers placed in the ecological islands along the perimeter road. We remind you that it is absolutely forbidden to unload special and / or bulky waste near ecological areas. The staff of the Camping Village is not authorized to collect and dispose of the aforementioned special waste. Below are the indications on the correct methods:

WET ORGANIC: All food remains (vegetables and fruit, meat and fish, including coffee and tea grounds, fish bones, egg shells, shellfish and bones), biodegradable animal bedding, toothpicks, wipes , handkerchiefs.

NO: non-biodegradable materials.

NON RECYCLABLE DRY: Cutlery, plates, plastic and ceramic cups, CDs, DVDs, dirty rags, rubber objects, broken toys, cotton, cotton swabs, diapers and panty liners, greaseproof paper, saucers, pens and paints, cosmetics.

NO: Recyclable materials, dangerous products, small appliances, old furniture and furnishings, garden equipment.

PLASTIC AND CANS: Bottles and flacons, cans for drinks and food, plastic and polystyrene trays, shopping bags, packaging for biscuits, plastic packaging for candies and sweets, yoghurt pots, nylon.

NO: objects in plastic and rubber, ceramic and porcelain, light bulbs. Remember to rinse the plastic and glass containers before throwing them away.

PAPER, CARDBOARD AND TETRAPACK: Cartons of packages and packaging, newspapers and magazines, tetrapacks, pizza boxes without food residues, photocopying and printing paper.

NO: carbon paper, greasy or dirty paper.

GLASS: Bottles, jars, jars and containers in general in glass.

NO: glass ceramics and oven dishes, ceramics and porcelain, crystal, light bulbs and neon lamps, containers for solvents.

OTHER WASTE

Expired batteries: in the appropriate containers at the Reception.

Bulky waste: small appliances, garden furniture and equipment must be reported to the reception.

Charcoal: it should be thrown into the wet after having carefully extinguished it.

Expired drugs: to be delivered to the nearest pharmacy

IMPORTANT: FOR ANY OTHER KIND OF BULKY AND / OR SPECIAL WASTE NOT MENTIONED, YOU MUST SEND AN EMAIL TO amministrazione@parcodellagallinara.com FOR A DISPOSAL QUOTE. IF YOU WANT TO PROCEED BY YOURSELF, WE REMEMBER THAT IT IS STRICTLY FORBIDDEN TO ABANDON WASTE INSIDE THE STRUCTURE.

INTERNAL CIRCULATION

46. The circulation of Campers' vehicles is allowed exclusively for the transport of heavy objects to the pitch and, in any case, respecting the speed limit of 10KM per hour, in the following time slots: from 10.00 to 11:00 and from 17:00 to 18:00.

47. Cyclists are required to respect the speed limits, turn on the lights during the evening hours and park their bicycles in the appropriate spaces.

48. It is forbidden to transit even with bicycles in the areas reserved to shows during their performance.

49. The use of electric bicycles and electric bikes is prohibited.

50. The use of non-electric bicycles is allowed (wakeboard, scooter, skateboard, roller). For children under 12, only under close adult supervision.

51. Only campers with disabilities, with walking difficulties and in possession of the legal permit, will have a parking lot near their pitch marked with their permit number and must in any case observe the hours of silence in which circulation is absolutely forbidden. . The car can be moved only with the presence on board of the badge holder. If the car is also used by family members, inside the campsite, it must be parked in the common parking lots.

52. In the event of violation of the preceding points, relating to internal road traffic, Ginestre Village S.R.L. may proceed with the immediate expulsion of the offender.

53. From 2:00 pm to 4:00 pm and from 12:00 pm to 7:00 am noises, screams, games and noises that may disturb the other guests of the structure are prohibited.

54. The Management reserves the right to remove without delay the Customers who, at its sole discretion, disturb the tranquility of the other guests or contravene the above rules.

FUN AND SPORT

55. The use of play areas by children is allowed only under the supervision of a parent or guardian of age.

56. For information on Archery, contact the Reception.

57. Inside the Camping Village it is forbidden to play football in the common areas.

58. To book padel, tennis and football fields, please contact the reception. Booking is mandatory and the balance must be paid at the time of booking. In case of cancellation of the booking within 24 hours prior to the event, the deposit will not be refunded although, the credit might be used for a new booking.

SERVICES

59. The opening days and hours of commercial services, catering, entertainment and other services such as shuttle, swimming pool and equipped beach, whose presence is guaranteed in the high season inside the Camping Village, may vary during the low season period.

60. At the Reception and at the points concerned, it is possible to view the various regulations and programs.

NURSERY SERVICE

61. The Camping Village is equipped with an infirmary service manned by a Doctor with Ambulance whose service hours are displayed at the Reception.

HOLIDAY IN SAFETY

62. It is allowed to keep a maximum number of 2 cylinders of 20 kg on the pitch in a shady spot. The application of chains, padlocks, locks that could hinder their removal if necessary is not allowed. Campers are required to verify that the connection of the cylinder to the system is correct and that the hose is up to standard.

63. Do not leave live electrical equipment in your absence.

64. Do not plug more than one electrical appliance into a single outlet. Do not use multiple plugs / sockets.

65. Do not light fires (except for those of cooking equipment) inside the housing units.

66. Inside the pitches and in the Camping Village in general, only the use of gas barbecues or electric grills is allowed.

67. It is forbidden to use unsupervised open flames (candles, citronella, torches, etc.).

The Management authorizes its staff to extinguish these flames if they are not supervised. Pay attention to the use of flammable fabrics and sheets.

EMERGENCY PLAN AND FIRE FIGHTING INSTRUCTIONS

The Gallinara Park has a fire emergency plan that will be duly implemented by the staff in case of danger.

68. All campers are required to be equipped with a FIRETEL ASSISTANCE S.r.l., 6 KG Powder ABC - 34 A 233 BC) fire extinguisher which will be placed at the entrance to the pitch on a special support. . These devices will be available, on loan for use, at the Reception of the Camping Village which will review them every 6 months. The cost of the aforementioned service, including revision, is € 40.00 to be paid no later than 20/03. This is a must in compliance with the fire regulations, so failure to place it will inhibit the use of the pitch.

69. Entry to the campsite will not be allowed unless in compliance with the placement of fire protection devices.

CONTROLLER (STAFF)

The control officer has the obligation to verify compliance with the Regulations by the Guests. He is also the person to contact for any emergency, report and information.

70. During access to the facility, the staff will be equipped with a device that will be used to read the bracelet. It is therefore mandatory to always carry the bracelets issued during the check-in phase with you and to facilitate the control operations. If you do not have a bracelet, you will be invited to report promptly at the reception office.

71. LIABILITY

The very nature of the Camping Village and the characteristics of the environment in which it is located imply the presence of natural disconnections of the terrain. For any event resulting from the aforementioned circumstances, the Management declines all responsibility.

72. While guaranteeing the continuous surveillance of the Camping Village, the Management is not liable for thefts and for the loss or theft of valuables.

73. The Management is not liable for damage caused by other Guests, by vandalism, by atmospheric events and natural disasters, by falling trees, branches or pine cones, by fire, by insects, by epidemics, by diseases, including those of plants .

74. As the Regulation (EU) 2016/679 guarantees, we inform you that the processing of personal data will be based on lawfulness and correctness, in full protection of the Guest's rights and in particular of his privacy. The Privacy Policy is available at the Reception.

75. The Management of the Camping Village has the right to suspend and / or expel those who do not respect the rules of these Regulations. Guests already expelled will not be able to access the Camping without a new, specific written authorization from the Management.

TERMINATION OF THE CONTRACT

76. Ginestre Village S.r.l. will be able to terminate the contract "by law", pursuant to art. 1456 of the Civil Code, at any time following the violation of the following rules of conduct provided for in this regulation:

- Articles 2,7,8,9,11,14,16,22,23,26,28,29,30,31,32,37,45,52,53,54,75.

In the event of non-payment by the Customer, within the peremptory terms indicated in art. 11 of the present camping holiday season contract, the sums provided as a deposit and the balance of the total

amount due ; in the event that Ginestre Village S.r.l. should provide for the termination of the contract by law due to the non-payment of the amount due by the Customer, the same Company will provide for the judicial recovery of the credit.

For any dispute relating to this deed, the exclusive jurisdiction of the Court of Rome is agreed, with the express exclusion of all possible competing courts.

SOLIDAL RESPONSIBILITY

77. All crew members who have reached the age of majority are jointly and severally liable with the crew chief for the payment of the consideration of the seasonal camping tourism contract and / or any penalties provided for in this contract, as well as for any compensation of the damage.

The undersigned camper declares to specifically approve pursuant to art. 1341 and 1342 of the Civil Code, the following clauses: 1,2,3,4,5,6,7,9,10,11,13,14,15,16,17,22,23,24,25,26 , 27,28,29,31,32,33,34,35,36,37,38,39,40,44,45,53,54,55,58,59,62,68,69,70,71 , 72,73,74,75,76 and 77.
