CAMPING & CARAVANING

Dear Guests, in welcoming you to the Parco della Gallinara Camping Village, the Management invites you to read these Regulations. The rules listed below are intended to create the best conditions for a respectful coexistence within the Camping Village, whose entry constitutes unconditional acceptance.

- 1** - Admission to the Campsite takes place through the check-in procedure in which the interested party must specify their personal details and those of the people making up their family unit, showing valid identity documents, license plate number of their car or motorbike or camper and the exact length of time he intends to stay.
- 2** - We will give you a pass bracelet, which must be worn for the duration of your holiday.
- 3** - The accommodation rates are those displayed at the reception at the entrance to the campsite.
- 4** - The pitches are available from 09:00 and must be vacated by 16.00 on the day of departure.
- 5** - Each pitch is well marked and numbered. All the crew must position themselves within its borders, considering an adequate distance to be kept from the neighboring pitches to ensure free passage, easy access to utilities and the evacuation route in case of emergency. It is forbidden to enclose the pitch.
- 6** - The installation of only one crew is allowed for each stand. Any installation exceeding the crew is subject to an extra fee.
- 7** - Each crew has the right to only one water outlet and one electrical outlet.
- 8** - The requested and accepted payment must be paid in full upon arrival. Departures after 16:00 will result in a payment charge equal to the entire daily rate of stay.
- 9** - Failure to use the pitch, partial or total, by the user for his specific cause, cannot constitute a right to request and obtain the reduction or even partial refund of the amount paid by him.
- 10** - The user cannot sublet by granting the pitch (for any reason whatsoever) to persons other than those designated by him at the time of his admission or from those mentioned in the contract.
- 11** - The concession for use of the pitch entitles the user to a single license plate included in the rate. In the

presence of a second number plate, the relative daily parking fee will have to be paid.

12 - After the cars have unloaded their luggage and accompanied guests, they must be taken to the appropriate parking area. Under no circumstances can cars occupy different spaces. For no reason an

exception to these obligations is granted.

13 - Circulation inside the Village-Camping, with cars or motorcycles is allowed only at the following times:
10:00 - 11:00 and 17:00 - 18:00 at speeds not exceeding 10 Km / h.

14 - Users are required to respect the hours of silence from 14:00 to 16:00 and from 24:00 to 8:00 and to use radios, televisions, etc ..., at a volume that does not cause I disturb.

15 - Commonly used parts cannot be cluttered or used for purposes other than those for which they were intended

16 - Pets are allowed, subject to registration at check-in and payment of the relative stay fee. The animals must be kept for the entire duration of the stay, led on a leash with a muzzle and their droppings must be collected immediately. All animals must be kept in such a way as not to disturb or damage other people or things. Their owners will be responsible for any damage to people or things. Pets are not allowed in the common areas (play areas, swimming pool, theatre, restaurant...) and it is forbidden to leave the animal on the pitch, tied, chained or in any case segregated. The pitch and all the areas used by the dog must be kept clean, using the special ecological bags to be placed in the special containers distributed on the main streets of the structure. It is forbidden to shower animals inside the toilets.

17 - Guests of the camper and tents area users are allowed, subject to the authorization of the Management.

GUEST VISITORS

- Customers can receive day or overnight guests by sending a request by email to reservation@parcodellagallinara.com. We remind you that the same must be communicated and the related passes paid for no later than the opening hours of the Fast Cash office displayed at the Reception. In the event that the guest arrives after closing time, they can collect the pass from the guardian if previously booked and paid for. **WITHOUT A PASS IT WILL NOT BE POSSIBLE TO ACCESS THE STRUCTURE.** We also remind you that customers are responsible for the behavior of their guests and must ensure that they are in possession of a regular pass.

- **OVERNIGHT VISITORS:** The maximum number of overnight guests in the Superior and Nice pitches is max 7 people and in the Easy pitch it is max 2 people. If there are beds available on your pitch, the overnight guests must carry out the check-in procedures, showing a valid identity document, pay for the stay, parking and tourist tax. A bracelet will be issued, which must be returned at the time of check out scheduled for 10:00 on the day of departure. In the event of non-delivery, the cost of the subsequent nights will be charged to the holder of the reservation until delivery of the same. In the case of a pet, the guest will have to pay the relevant pass of € 5.00 provided for access to the facility.

In compliance with the provisions of art. 109 of the TULP (Consolidated Law on Public Safety), minors can access the campsite with a valid identification document in addition to the authorization signed by both parents, together with a copy of an identification document of the latter, or accompanied by adults who are the legal responsible. The model of this authorization can be downloaded in the download section of our official website.

- **DAILY VISITORS:** Access allowed from 08:00 to 23:30. A pass will be issued which must be returned to the control staff at the exit. In the event of non-delivery, the cost of the subsequent nights will be charged to the holder of the reservation until delivery of the same. In the case of a pet, the guest will have to pay the relevant pass of € 5.00 provided for access to the facility.

- Anyone caught in the Village-Camping without registration will be reported for trespassing pursuant to Art. 614 C.P. The user surprised with guests not properly declared and registered in the Management will be removed from the structure. The Management also reserves the right to take personal action against those responsible pursuant to Articles 614, 624, 633 and 637 of the Criminal Code.

- We remind you that after 18:00 you will pay only and exclusively for the parking. No pass will be issued and the tax receipt issued by the Cassa Veloce will be valid.

18 - People surprised inside the Village-Camping without registration will be reported for trespassing pursuant to Art. 614 C.P. .. The user surprised with guests not duly declared and registered in the Management will be removed from the structure. The Management also reserves the right to take personal action against those responsible pursuant to Articles 614, 624, 633 and 637 of the Criminal Code.

19 - The assignment of the pitch takes place at the sole and unquestionable criterion of our staff.

20 - It is strictly forbidden to light fires of any kind throughout the campsite. As far as "grilled" cooking is

concerned, this is allowed only by using the special equipped public barbecue areas that can be used by guests whose load will remain clean after use.

21 - It is strictly prohibited:

- Change pitch without being previously authorized by the Management;
- Damage equipment and plants and drive nails into trees;
- Throwing papers or rubbish outside the appropriate containers;
- Throwing away cigarettes and cigars without making sure that they are extinguished;
- Use the water from the fire-fighting vents that are used exclusively and strictly, together with the fire extinguishers, for the use for which they are intended;
- Wash dishes and linen outside their respective sinks;
- Enclose the respective positions with reeds, fences or other material;
- Install sheets covering the stations and sheets like carpet or other flooring of a permanent nature;
- Digging dimples or canalizations;
- Pour boiling or salty or waste liquids on the ground;
- Children's access to the toilets and the playground is allowed only if accompanied by an adult.

22 - It is forbidden to connect pipes to the taps of the water columns, wash cars and equipment in the camping area. Furthermore, it is forbidden to use the water from these columns for uses for which they are not designed (eg: washing clothes, dishes, personal hygiene etc ...).

23 - Each user is required to keep the things he owns. In this regard, the Management declines all responsibility and is not liable in any case for any theft, damage or shortages that may occur to the detriment of users. Likewise, the Management is not responsible for valuables, vehicles, tents, caravans, campers, furniture, clothing and other objects, owned by users, whose loss or damage derives from causes of force majeure or fire.

24 - The opening hours of the offices and the various services are those displayed in the individual rooms used for this purpose.

25 - Any infectious disease must be reported immediately to the Management.

26 - The Management may remove from the Village-Camping those who violate the laws of P. S. or the provisions of this regulation and those whose behavior disturbs others or who does not comply with the

rules of good manners and civility.

27 - Behaviors contrary to the provisions of these conditions for the stay entitle the Management to expel the user and his family unit, reserving all civil and criminal actions.

28 - Entry to the Campsite implies acceptance and full compliance with these Regulations, which may be supplemented by additional provisions that the Management deems appropriate to issue, for the better functioning of the structure. The staff is authorized to enforce it and to report any non-compliance to the Management. Offenders will be immediately removed from the campsite.

29 - No possible temporary derogation from this regulation can constitute an acquired right.
